Caroline Feeney is CEO, U.S. Insurance & Retirement for Prudential Financial, Inc., and is responsible for the company's entire U.S. portfolio of Prudential-branded businesses. This includes approximately eight thousand associates across Group Insurance, Individual Life Insurance, Prudential Retirement Strategies, and the Retail Advice and Solutions organization. Feeney is also responsible for several of Prudential's key functions, including Enabling Solutions, which provides operational service and support to Prudential's customers and Enterprise Capabilities, which manages Prudential's key external partnerships and the company's financial wellness programs.

Together, this segment provides financial advice and develops, distributes and services income and protection solutions for Prudential's retail and institutional clients, and generates approximately fifty percent of Prudential's overall earnings.

Feeney is Prudential's representative for the National Association for Female Executives and serves on its Executive Roundtable. She also represents Prudential on the Board of the Alliance for Lifetime Income, the Forbes/Shook Research Advisory Board, and the LL Global Board of Directors, where she serves on the Finance and Compensation and Benefits committees. Within Prudential, Feeney is the executive sponsor of Women Empowered, Prudential's employee-focused business resource group, and a trustee of Prudential's Corporate Social Responsibility Oversight Committee. In this role, Feeney helps guide the company's foundation and its investments to strengthen communities and realize Prudential's belief that financial security should be within reach for everyone. Feeney is also a member of Fortune's Most Powerful Women, and in 2018 became the first woman to receive the Round Table of New York's Lifetime Achievement Award.

Previously, Feeney served on The American College Board of Trustees and on the Executive Committee of the Board, the Marketing Committee, and chaired the Nominating Committee. She also served on the Advisory Board for The American College Center for Ethics.

Feeney is a past recipient of the Garden State Woman Education Foundation Corporate award, as well as the Trailblazer Award by the National Council for Research on Women. In addition, she has been recognized by Working Mother Magazine as Prudential's Working Mother of the Year, by Executive Women of New Jersey as Prudential's Policy Maker, and was an honored recipient of the Women of Excellence P&L Award from the National Association of Female Executives.

Prior to her current role as CEO, U.S. Insurance and Retirement Businesses, Feeney was CEO of Prudential's Individual Solutions Group. During her career with Prudential, Feeney has held several distribution leadership positions and home office executive roles, including president of Prudential Advisors, which is Prudential's national sales organization, and President of Individual Life Insurance.

Feeney earned her MBA from Columbia University and a bachelor's degree from Bucknell University. She holds the Chartered Life Underwriter and Chartered Financial Consultant designations.
